

## **American Digger Events Show Rules**

**By purchasing display or sales tables/space at any American Digger artifact show, you agree to abide by all rules and regulations put forth in this document and detailed below:**

### **EXHIBIT/SALE ITEMS:**

Sale and display items are restricted to artifacts made before 1945. Dealers are responsible for their own firearm licensing, including an FFL or other license as prescribed by law for post-1898 weapons. Dealers without an FFL may sell antique weapons prior to 1898 vintage. Under no circumstance will any post-1945 firearms be traded, sold, or displayed on the show hall property. All cartridge firearms must have the hammer or action tied shut to render them inoperable. It is your responsibility to know and abide by all laws involving the sale or transfer of any weapons, and you alone will be held responsible.

In addition to the above, no loaded firearms will be allowed in the hall, with the exception of show security personnel.

All artillery shells must be disarmed or inert, and no live explosives of any kind will be allowed on the premises. This includes bulk black powder or other volatile substitute.

Any reproduction or fantasy pieces must be sold as such and clearly marked. Modern souvenirs, i.e. bumper stickers, license plates, t-shirts, etc. may be sold only with prior approval. We reserve the right to have any materials we deem inappropriate removed from a sale or display table.

### **BADGES**

Vendor/exhibitor badges must be worn at all times during the show. These should be picked up at the registration table before you enter the exhibitor area. Please submit the names you wish on your badges at least 14 days before the event. Badges are non-transferable, and no blank badges will be issued. The table holder is responsible for seeing that any badges issued to him are worn only by the person whose name appears on it.

### **TABLES**

All table/space fees must be paid in full no later than two weeks prior to the event. Fees received after that date will not be guaranteed a table or preferred location. American Digger welcomes the public to our events. Many are experiencing a show like this for the first time. To

provide them with the full experience, tables must be completely set up and remain uncovered during public show hours. Tables must also remain set up and uncovered until closing (3 PM) on Sunday unless prior arrangements are made. To present a professional look to the public, vendors/exhibitors must provide and use table covers.

**LIABILITY:**

All badge-holders are legally responsible for any accident that may occur as a result of mishandling of any items at their table or in their charge. American Digger Events, the event venue, and their employees are not responsible for any accidents or thefts. Each vendor/exhibitor is responsible for the security of his table. Our shows provide 24-hour on-site armed security. Even so, we are not responsible for losses of any kind, damage, theft, or injury. We advise against leaving tables unwatched and unmanned.

Please note that no alcohol consumption or public intoxication is allowed on the premises at any time during the show.

**CANCELLATION POLICY:**

Any cancellations must be received two weeks (14 days) ahead of time and must be received directly from the vendor/exhibitor and not through a third party. Any cancellations received after that time may result in forfeiture of all fees paid. Refunds or credits for such cancellations are solely at the discretion of American Digger Events. "No-shows" may forfeit their right to location choice or table space at future shows.

**SALES TAX:**

All dealers are responsible for and required to accurately record, report, and pay any applicable sales tax.

**By renting a table/space for this show, you agree to abide by these regulations.**

**Violations may result in eviction from the facility and/or prosecution.**

**American Digger Events reserves the right to expel anyone creating a disturbance or exhibiting improper or unacceptable behavior, in the opinion of any show representative.**

**Violation of show rules or regulations may result in expulsion. We also reserve the right to bar anyone connected with disturbances at past shows from attending future events.**
